Bhagwan Parshuram Institute of Technology will conduct Physical counseling for admission in BBA and B.Tech (LE) Programme under Management Quota from the Merit Ordered List already displayed on Institute's website as per the schedule given below:

Important Instructions for the candidates participating in offline Counselling for admission in B.Tech Programme under Management Quota in Bhagwan Parshuram Institute of Technology.

1. Candidates are required to adhere strictly to the entry/reporting timings (9:30 a.m. to 10:30 a.m.) as latecomers will not be allowed to participate in Counselling.
2. Candidates shall bring the following documents in Original along with two self attested copies for verification/deposition in the Institute on the day of physical counseling/Allotment of seats under Management Quota:
 - a) CET/CUET Admit Card (Original & Photocopy).
 - b) Copy of Rank obtained in CET/CUET 2023.

- c) Original Certificates and Mark sheets of qualifying examination along with two sets of self attested photocopies.
 - d) Reserved Category candidates shall bring original reserve category certificates issued by the competent authority as notified in Admission Brochure of GGSIP University with two sets of self attested copies.
 - e) Physical Fitness Certificate on the format given in Admission Brochure 2023 of University.
 - f) A Demand Draft of Rs. 1,77,900/- (Rupees one lac seventy seven thousand nine hundred only) for B.Tech(LE) and Rs. 1,45,800/- (Rupees one lac forty five thousand and eight hundred) for BBA respectively, drawn in favour of Bhagwan Parshuram Institute of Technology payable at Delhi towards academic fee.
3. Only those candidates whose name appear in Merit Ordered List will be allowed to participate in Counselling for admission under Management Quota. Merit Ordered List contains the names of those candidates, who applied online on University's portal & online/offline in the Institute and have got their eligibility verified by the Institute on 08/08/2023, 09/08/2023, 26/08/2023 and 28/08/2023.
 4. Only Candidates with **NOT Admitted Status** will be eligible to take part in the Counselling for admission in management quota. (Not admitted means a candidate who has neither taken admission in any of the Institutes affiliated to GGSIPU nor in GGSIP University itself).
 5. A candidate, who has already taken admission in any Institute through online Counselling conducted by the University or under Management Quota in any of the Institutes affiliated to GGSIPU, shall not be eligible for consideration of seat allotment under Management Quota.
 6. A candidate once admitted in any Institute/college, under Management Quota seats, will not be eligible to take admission in any other college affiliated to GGSIPU.
 7. Every candidate shall submit an undertaking to the effect that he/she has neither taken admission in any of the Institutes affiliated to GGSIPU nor in GGSIP University itself.
 8. Candidates will be called strictly in the order of merit as appeared in the merit ordered list drawn on the basis of aggregate percentage of marks in qualifying examination, which has already been displayed by the Institute.
 9. Only candidate will be allowed to enter the Institute premises. Identity of every candidate participating in Counselling will be verified at the entry point on the basis of original Photo ID such as Aadhar Card/Passport/PAN Card/DL etc)

10. Laptops, mobile phones, smart watches or any other electronic gadgets will be strictly prohibited to carry in the Institute premises. The candidates can carry only a water bottle with them. Kindly note that the Institute will not make any arrangement for safe custody of these items at all.
11. All Reserved category candidates (SC/ST/DEF/PH) and Un-reserved category candidates of Delhi/Outside Delhi region shall be present physically along with the original documents for verification at the time of Counselling. They are required to bring Original + two self-attested photocopies of all requisite documents at the time of Counselling else they will not be entitled for participation in the offline Counselling for allotment of seat.
12. Admission of the candidate will be confirmed under Management Quota only after deposition of the Institute' fees in full i.e Rs. 1,77,900/- (Rupees one lac seventy seven thousand nine hundred only) for B.Tech(LE) and Rs. 1,45,800/- (Rupees one lac forty five thousand and eight hundred) for BBA on the same day of allotment of seat, failing which the offered seat shall automatically stand cancelled and the same shall be allotted to the next candidate in merit.
13. **The fee will be paid by Demand Draft only drawn in favour of Bhagwan Parshuram Institute of Technology payable at Delhi. No candidate will be allowed to participate in Counselling if not holding the Demand Draft of Rs. 1,77,900/- B.Tech(LE) and Rs. 1,45,800/- for BBA**
14. Institute fees once deposited after accepting the seat under management quota will not be refunded.
15. The entire session of Counselling/Admission will be video graphed.
16. All admissions are provisional subject to the ratification by the University.
