ii. Grievance Redressal mechanism for Faculty, staff and students	The Institute has constituted a Grievance Redressal Committee for redressing the grievances of teaching and non-teaching faculty members & other stake holders as well. Besides, the Institute has constituted a Students Grievance Redressal Committee too under REDRESSAL OF GRIEVANCE OF STUDENTS REGULATIONS 2019 for redressal of student's grievances. Both the Committees are uploaded on Institutes' website for dissemination among all concerned. To facilitate online submission of complaints/grievance, a form has been created at Institute's website itself besides, providing of e-mail addresses of all members of the Committee, where any affected person can lodge his/her grievance. The Institute has also installed a complaint/Grievance Box at all floors of the Institute, where any person including students can put their complaint/grievance into this Box. On receipt of any grievance from any staff member or any other stakeholder, the meeting of Grievance Redressal Committee is convened, and the grievance is placed before it for redressal. The Committee examines the pros and cons of the grievance and affords the person an opportunity to adduce all kinds of evidence in his/her support. After examining all oral or documentary evidence, the Committee gives it verdict for redressal of grievance. If the person is not satisfied with the Committee's decision, he/she may file an appeal before the Ombudsman of GGSIP University for further redressal of his/her grievance. A report of Grievance received, and its disposal is sent to AICTE and GGSIP University every month. Proper files are being maintained containing monthly reports. Grievance Redressal Committee holds a periodical meeting notwithstanding no grievance is received by it. After every GRC meeting, minutes of meetings are drawn mandatorily and placed on record in the GRC file.
