Bhagwan Parshuram Institute of Technology will conduct Physical counseling for admission in MBA, BBA, B.Tech and B.Tech (LE) Programme under Management Quota from the Merit Ordered List already displayed on Institute's website as per the schedule given below:

Important Instructions for the candidates participating in offline Counselling for admission in B.Tech Programme under Management Quota in Bhagwan Parshuram Institute of Technology.

1. Candidate are required to adhere strictly to the entry/reporting timings (9:30 a.m. to 10:30 a.m.) as latecomers will not be allowed to participate in Counselling.
2. Candidates shall bring the following documents in Original along with two self-attested copies for verification/deposition in the Institute on the day of physical counseling/Allotment of seats under Management Quota:
 - a) JEE Mains/CET/CUET Admit Card (Original & Photocopy).
 - b) Copy of Rank obtained in JEE Mains/CET/CUET 2024.
 - c) Original Certificates and Mark sheets of qualifying examination along with two sets of self attested photocopies.
 - d) Reserved Category candidates shall bring original reserve category certificate issued by the competent authority as notified in Admission Brochure of GGSIP University with two sets of self attested copies.
 - e) Physical Fitness Certificate on the format given in Admission Brochure 2024 of University.

- f) A Demand Draft of Rs. 1,88,000/- (Rupees one lac eighty eight thousand) for B.Tech, B.Tech (LE) and Rs. 2,21,000/- (Rupees two lac twenty one thousand only) for MBA and Rs.1,54,300/- (Rupees one lac fifty four thousand three hundred only) for BBA respectively, drawn in favour of Bhagwan Parshuram Institute of Technology payable at Delhi towards academic fee. Candidates, who will not bring the DD of the aforesaid amount will not be allowed to attend counseling.
- g) An affidavit on stamp paper of Rs.10/- (already provided on BPIT website).
3. Only those candidates whose name appear in Merit Ordered List will be allowed to participate in Counselling for admission under Management Quota Merit ordered list contain the names of those candidates who applied online/offline on the institute 's website and in the institute office.
 4. Only candidates with **NOT ADMITTED STATUS** will be eligible to take part in the Counselling for admission in management quota (Not admitted means a candidate who has neither taken admission in any of the Institutes affiliated to GGSIPU nor in GGSIP University itself.)
 5. A candidate, who has already taken admission in any institute through online Counselling conducted by the University or under Management Quota in any of the Institutes affiliated to GGSIPU, shall not be eligible for consideration of seat allotment under Management Quota.
 6. Every candidate shall submit an Affidavit on a stamp paper of Rs.10/-, whose specimen is annexed, to the effect that he/she has neither taken admission in any of the Institutes affiliated to GGSIPU nor in GGSIP University itself.
 7. Candidates will be called strictly in the order of merit as appeared in the merit ordered list drawn on the basis of aggregate percentage of marks in qualifying examination, which has already been displayed by the Institute.
 8. Only candidate will be allowed to enter the Institute premises. Identity of every candidate participating in Counselling will be verified at the entry point on the basis of original Photo ID such as Aadhar Card/Passport/PAN Card/DL etc.)
 9. Verification of all documents will be conducted on the day of counselling.
 10. Laptops, mobile phone, smart watches or any other electronic gazettes will be strictly prohibited to carry in the Institute premises. The candidates can carry only a water bottle with them kindly note that the Institute will not make any arrangement for safe custody of these items at all.
 11. All Reserved category candidates (SC/ST/DEF/PH) and Un-reserved category candidates of Delhi/Outside Delhi region shall be present physically along with the original documents for verification at the time of Counselling. They are required to bring Original plus two self-attested photocopies of all requisite documents at the time of Counselling else they will not be entitled for participation in the offline Counselling for allotment of seat.
 12. Admission of the candidate will be confirmed under Management Quota only after deposition of the Institute fees in full i.e. Rs. 1,88,000/- (Rupees one lac eighty eight thousand) for B.Tech, B.Tech (LE) and Rs. 2,21,000/- (Rupees two lac twenty one thousand only) for MBA and Rs.1,54,300/- (Rupees one lac fifty four thousand three hundred only) for BBA on the same day of

- allotment of seat, failing which the offered seat shall automatically stand cancelled and same shall be allotted to the next candidate in merit.
13. In the inter-se-merit of candidates securing equal aggregate percentage in class 12th, following criteria will be adopted to determine the merit:
- In case of candidates securing equal aggregate percentage, then the candidate getting higher marks in Mathematics of the qualifying examination.
 - In case of tie in (i) above, the candidate getting higher marks in Physics of the qualifying examination.
 - In case of tie in (i) and (ii) above, the candidate getting higher marks in Chemistry/ Computer Science / Electronics / Information Technology / Biology / Informatics Practices/ Biotechnology / Technical Vocational subject / Agriculture/ Engineering Graphics / Business Studies/ Entrepreneurship in the qualifying examination.
 - In case of tie in (i), (ii) and (iii) above, the candidate older in age shall rank higher.
14. **The fee will be paid by Demand Draft only drawn in favour of Bhagwan Parshuram Institute of Technology payable at Delhi. No candidate will be allowed to participate in Counselling if not holding the Demand Draft of the amount referred to above.**
15. Institute fees once deposited after accepting the seat under management quota will not be refunded.
16. The entire session of Counselling/Admission will be video graphed.
17. All admissions are provisional subject to the ratification by the University.
