### Important Notice for Students Regarding Academic Bank of Credits (ABC) ID

As per instructions received from GGSIPU and Govt. of India, all the students of BPIT (B.Tech. –3<sup>rd</sup>, 5<sup>th</sup> & 7<sup>th</sup> semesters, BBA – 3<sup>rd</sup> & 5<sup>th</sup> semesters and MBA – 3<sup>rd</sup> Semester) are hereby informed that it is mandatory to register on Academic Bank of Credits (ABC) Portal (<https://www.abc.gov.in/>) and DigiLocker Portal (<https://www.digilocker.gov.in/>).

From the next semester onwards, the result of the University will be declared using ABC ID. Therefore, the students should have a valid ABC ID and Aadhar Number. Also note that no printed marksheets will be issued to the students. The marksheets of all the semesters will be downloaded using the same ABC ID through Digilocker only.

Many students have already provided the ABC ID and Aadhar Number through Google form but even after several reminders, some students have not submitted the details yet. In view of the above, you are advised to verify your details available with the respective mentor, if you have submitted the details earlier. In case you have not submitted your details to the mentor then you should submit the same by 09/09/2024.

**Note:** In the interest of all the students, this is the final opportunity provided by the University. If any student fails to submit the requisite details or submits the incorrect details then the respective student will solely be responsible for their non-declaration of result / non-issuance of marksheet. The institute will not be held responsible for the same.
